### Stimulus Checks

Some New Mexico families may be owed thousands of dollars in unclaimed federal stimulus checks. These checks, if delivered and spent, could offset hardship and boost local economies. About 124,000 mostly low-income New Mexicans have have until Oct. 15 to file a tax return or complete an online IRS form to trigger release of their checks.
